

# ELECTRONIC KEYBOX REDISAFE PURCHASE AGREEMENT

This agreement is made and entered into by and between the WEBER/NORTH DAVIS ASSOCIATION OF REALTORS® (WNDAR) and \_\_\_\_\_ (the keybox holder) who is a \_\_\_\_ principal broker; \_\_\_\_ branch broker; \_\_\_\_ sales associate for \_\_\_\_\_ (firm name) \_\_\_\_\_ (broker)

1. Electronic Keybox Receipt. Key box Holder hereby acknowledges receipt of keyboxes listed on attached installation receipt.
  - (a). PRICE – the cost of each RediSAFE is \$105. Said price is subject to change from time to time, as deemed necessary by WNDAR.
2. Use of Key box. Key box Holder agrees to:
  - (a). Use the key box in compliance with the rules and regulations as adopted by the WNDAR and as modified and published from time to time.
  - (b). Never attach the PIN code to the Key, not to divulge his/her Key PIN code to anyone, never duplicate or attempt to duplicate the Key, and not allow any other person to use his/her key for any reason at any time.
  - (c). NEVER place a key box on a property along with a non-recording lockbox.
  - (d). Safeguard the SHACKLE CODE and CALL BEFORE SHOWING CODE of each key box from other systems users and non-users.
  - (e). Notify the WNDAR immediately, in writing, of the loss or theft of the key box and the circumstances surrounding such loss or theft.
  - (f). Notify the WNDAR in writing, if key box Holder sells, trades, or otherwise transfers key box to another party. Such notice shall include the name of the transferee and the serial number of the key boxes transferred.
  - (g). Comply with all security procedures for use of key boxes as specified from time to time by the WNDAR.

\* Any violation of the terms and conditions of this agreement may result in a fine and/or revocation of keyholder's license to use ReaderKEY.
3. Definitions. As used in this agreement, the following terms and phrases shall have the respective definitions as set forth as follows:
  - (a). WNDAR shall mean the Weber/North Davis Association of REALTORS®, its officers, directors, agents, employees, and its successors and assigns.
  - (b). Key Box Holder shall mean the individual principal broker, branch broker or sales associate of a real estate brokerage company who accepts responsibility for and signs for the key box(s), or if the real estate company is responsible for the key box(s), the authorized agent for the real estate company.
4. Inspection and Audits. WNDAR shall have the right to inspect all key boxes held by key box Holder at all reasonable times and places. In addition, key box Holder agrees, if required by WNDAR, to submit all key boxes for inspection on an annual basis for key box audit and at any other time, upon oral request, if the WNDAR believes that the integrity and security of the electronic key box system is in jeopardy.
5. Indemnification. Key box Holder covenants and agrees to indemnify and hold the WNDAR, the participating Associations/Boards, and their officers, directors, and employees of the WNDAR and/or the participating Associations/Boards harmless from any and all liability, claims, causes of action, suits, obligations, or demands asserted against the WNDAR and/or the participating Associations/Boards as a result of key box Holder's loss or use of the key box(s), including, but not limited to, attorney's fees incurred by the WNDAR and/or the Participating Associations/Boards as a result of damages or injury to premises or persons arising out of the use by key box Holder or by any other person of the key box(s).
6. Authorizations. Key box Holder will secure authorization from the owner and/or tenant, if required by the tenant's lease, in possession of any property listed for sale or lease prior to the installation and use of an electronic key box on such property. Extreme care should be taken to ensure that the property is secured and the electronic key box is operating properly.
7. Miscellaneous. (a) All costs and expenses, including attorney's fees, incurred by WNDAR while enforcing all or part of this contract are the responsibility of the Holder and Broker jointly. (b) If any provision of this agreement is determined to be ineffective or invalid, all other provisions of this agreement shall remain effective and valid. (c) The Broker confirms he/she is a licensed real estate broker and a REALTOR® member of the WNDAR. The Broker also confirms the Holder is associated with the Broker in an active effort to sell real estate through the same business office. The Broker understands he/she will be jointly liable for any misuse of the ReaderKEY, RediSAFE, and the Broker understands, and agrees, any fees incurred by the Holder becomes the brokers responsibility and will be billed to their office account. (d) No covenant or condition of this agreement can be waived, except by written consent of WNDAR.
